In the upcoming policy note on food security, the Dutch government strives to connect Dutch expertise with local knowledge and innovation to enhance food security, and the need for food system transformation is emphasized. Although the role of innovation in sustainable food systems is increasingly acknowledged, less attention has been given to the question of what innovation actually entails and how innovation thinking can help to make food system approaches more effective. This seminar aims to bring a large existing Dutch body of practice and -theory on agricultural innovation together and explore how new insights can be put to use for global food security. During this seminar, policy-makers, researchers, and private sector representatives and other practitioners will collaboratively explore the questions below.

## Key questions are:

- What is the role of innovation thinking in food system approaches? Why does it matter?
- How can innovation thinking be adopted in practice? What are challenges and successes?
- How can policy-makers use and support innovation thinking in their policies and programmes?

Through four practical cases we will identify how innovation thinking can be applied in practice, what barriers can be encountered and what the successes are. Attention will also be given to what works and doesn't work in scaling these successes, and how these lessons learned can inspire the implementation of Dutch ambitions for food security. Join this interactive session and share your expertise to integrate agricultural innovation in the food security agenda.
